



## Linking Agreement

This Linking Agreement (“Agreement”) is made between \_\_\_\_\_ (“Linking Entity”) whose homepage URL is \_\_\_\_\_, and the County of Kaua’i who maintains a Web site with homepage URLs of “www.kauai.hawaii.gov,” “www.kauai-hi.gov,” “www.co.kauai.hi.us” or “www.kauaicountyhi.gov” (“COUNTY”).

The parties agree as follows:

WHEREAS, Linking Entity desires to place a hypertext link on its Web site which will allow users of the Web site to access certain pages of the Web site of the COUNTY;

WHEREAS, COUNTY is willing to grant permission to Linking Entity to establish the hypertext link in accordance to the terms and conditions contained in this agreement;

NOW, THEREFORE, IT IS HEREBY AGREED AS FOLLOWS:

Subject to the provisions in this Agreement, COUNTY hereby grants to Linking Entity permission to place a hypertext link on Linking Entity’s Web site as follows:

- A. The link on Linking Entity's Web site must use **one of the** following **base** URLs:

If Linking Entity wishes to link to a subpage of the County's Web site, the link must use **one of the** following **base** URLs:

The actual URL used by the Linking Entity will depend on the particular page, subpage or Web site being linked.

- B. The COUNTY reserves the right to change its Web site at any time without notice. Accordingly, it is the responsibility of the Linking Entity to continuously verify its links to the COUNTY's Web site.
- C. Linking Entity shall not capture the COUNTY's Web site, subpage or content within its frames, or otherwise present the COUNTY's Web site, subpage or content as its own.
- D. Linking Entity's link to the COUNTY's Web site, subpage or content should be a full forward link that passes the client browser to the COUNTY's Web site unencumbered. The BACK button should return the visitor to your site if the visitor wishes to back out.
- E. Linking Entity shall not link to individual graphics or tables within the COUNTY's Web site, subpage or content of the COUNTY's Web site, especially in an effort to place the downloading burden on the COUNTY's servers. Such an action will be treated by the COUNTY as exceeding the permission granted by this Agreement, as well as misuse of the COUNTY's Web site, subpage or content, and the associated computer system.
- F. The COUNTY maintains and will defend a copyright interest in its Web site, subpage and content.

## Extension of Term of the Permission

By mutual written consent of Linking Entity and the COUNTY, the term of the permission granted in this Agreement may be extended.

## Termination or Revocation of Agreement

At any time, Linking Entity may terminate or revoke this Agreement, with or without cause. At any time, COUNTY may terminate or revoke this agreement, with or without cause. Any termination or revocation of this Agreement shall take effect as follows:

1. On the 3<sup>rd</sup> day after notice of the termination or revocation of this Agreement has been sent by email to the contact person; or
2. On the 7<sup>th</sup> day after notice of the termination or revocation of this Agreement has been sent by mail to the contact person; or
3. As may be otherwise agreed in writing by the Linking Entity and the COUNTY.

## Amendments

This Agreement may be amended by mutual written consent of Linking Entity and the COUNTY.
